- Local Rules and Definitions -
- Flower Beds: The flower bed is no play zone. If a player's ball lies in the area, or it physically interferes with the player's area of intended stance or intended swing, the player must take relief (See Rule 16.1f).
- Out of Bounds: Fence posts on No. 1; markers near clubhouse; Nos. 9 and 18 greens beyond the cart path; and white stakes, defined by their inside edge at ground level on Nos. 1, 2, 3, 4, 10, 11 and 12.
- Red Penalty Areas: Left and behind No. 4; river on Nos. 12, 13 and 14; and pond on No. 14, identified by red stakes and defined by red lines. In the absence of red lines, red stakes will define the margin of the penalty area.
- Tall Fescue: Tall fescue areas are treated as red penalty areas. Tall fescue areas are identified by red stakes and defined by the edge of the tall fescue area.
- Model Local Rule F5: Player may take free relief from immovable obstruction (sprinkler head), that is on the line of play, within two club lengths of putting green and within two club lengths of the ball. (Rule 16.1 b applies)

- No carts allowed in tall fescue areas or within 30 feet of tees and greens.
